Pursuant to the Statutes of the State of Florida, the undersigned individual submits these Articles of Incorporation for the purpose of forming a corporation.

ARTICLE I
Name and Initial Office

The name of the Corporation is Island Lawncare, Inc. and the principal place of business and mailing address is 1900 Post Road, Unit 251, Melbourne, Florida, 23935.

ARTICLE II
Duration

The Corporation shall have a perpetual existence.

ARTICLE III
Purpose

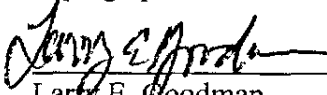
