Articles of Incorporation

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

**ARTICLE 1 – Name**

The name of the corporation is Ed Zaunbrecher's coachz.org., Inc.

**ARTICLE 2 – Principal Office**
