## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I

The name of this Corporation is: RHINO LININGS OF OKEECHOBEE, INC.

## ARTICLE II

The duration of the Corporation is perpetual.

## ARTICLE III

The general purposes for which the Corporation is organized are: To operate any lawful business.

## ARTICLE IV

The aggregate number of shares which the corporation is authorized to issue is TEN THOUSAND (10,000). Such shares shall be of a single class, and shall have \$1.00 par value.
