Business and Activities. This corporation may, and is sutherized to, engage in any activity or business permitted under the laws of the United States and of the State of Florids.

ARTICLE IV

Capital Stock. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 2,000 shares of common stock having \$1.00 par value, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

ARTICLE VI

Number of Directors. This corporation shall have two (2) Director(s) initially.
