**ARTICLES OF INCORPORATION FOR
LFP CONSULTING, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is LFP CONSULTING, INC.

ARTICLE II
NATURE OF BUSINESS

The corporation shall be engaged in the business of operating an insurance/business consulting service and/or any other lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding is Five Hundred (500) shares of common stock, each having \$1.00 par value. 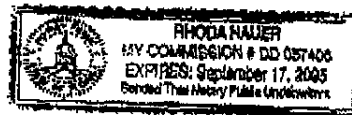



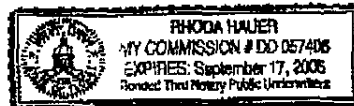
