**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is Buccaneer Marine Service Inc.

The principal place of business of this corporation shall be: 9 SW 13<sup>th</sup> Street, Fort Lauderdale, FL 33315.

**ARTICLE II: DURATION**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
