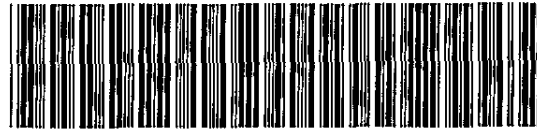



Article XIII – Amendment



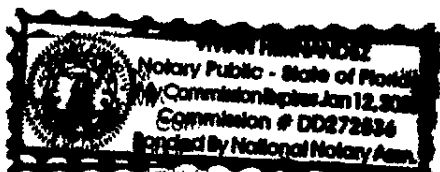



