ARTICLE I – NAME

The name of this corporation is **Main Street Title Company, Inc.**

ARTICLE II – DURATION

This corporation is to have perpetual existence.

ARTICLE III

The nature of the business of this corporation shall be to engage in any lawful business allowed under the laws of the State of Florida, and shall have all of the powers enumerated under Florida Law.

ARTICLE IV – CAPITAL STOCK

The capital stock of this corporation shall consist of one thousand shares of common stock having a nominal or par value of Fifty Cents (\$.50) per share. The whole, or any part of the capital stock of this corporation, shall be payable in lawful money of the United States of America, or property, labor or services at a just valuation to be fixed by the directors. The shareholder of the corporation shall have preemptive rights as to any unissued or treasury stock on a pro-rata basis.

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

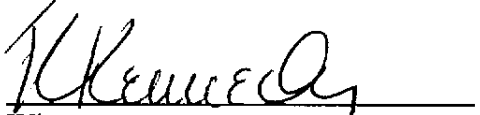
ARTICLE XIV – AMENDMENT

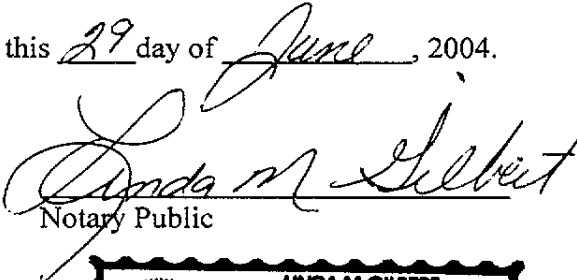

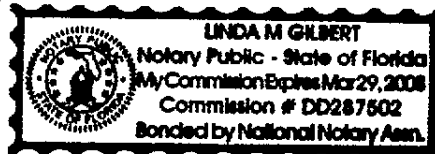
