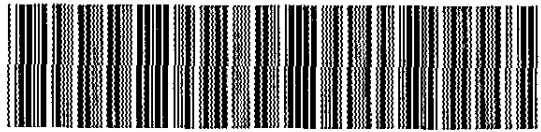

ARTICLE IV INITIAL REGISTERED AGENT AND STREET ADDRESS

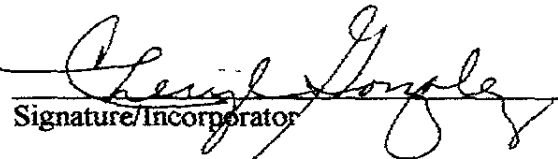

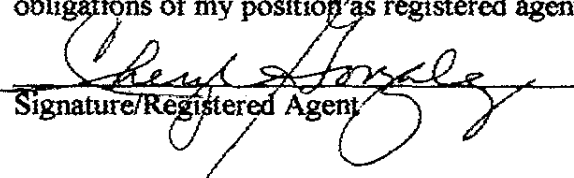
