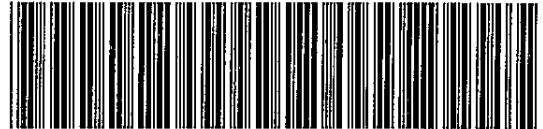

THE UNDERSIGNED, for the purpose of forming a corporation pursuant to Chapter 607 and Chapter 621, of the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation shall be:

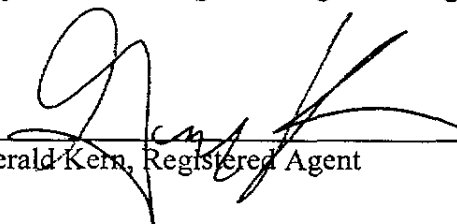
