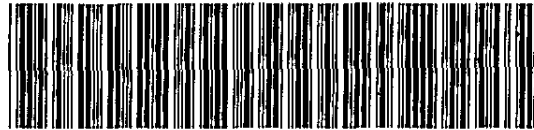

**ARTICLE I - NAME**

The name of the corporation formed pursuant to these Articles of Incorporation is SRI Property Management, Inc.

**ARTICLE II - DURATION**

**ARTICLE III - PURPOSE**




