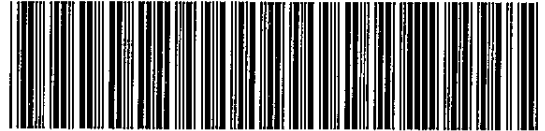

NAME OF CORPORATION

The name of the corporation shall be COX ENTERPRISES OF EDGEWATER, INC.

ARTICLE II

NATURE OF BUSINESS
