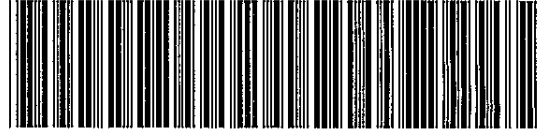



ARTICLES OF INCORPORATION
OF
