## ARTICLE I. CORPORATE NAME.

The name of this corporation is C & M STUDER, INC.

#### ARTICLE II. PRINCIPAL OFFICE.

The initial principal place of business of this corporation is 1644 White Oak Road, Orange Park, FL 32003, and the initial mailing address of this corporation is the same.

#### ARTICLE III. DURATION.
