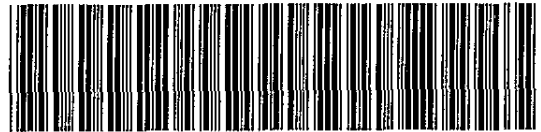

ARTICLE II - DURATION


