ARTICLES OF INCORPORATION

OF

COUNTRY MOTORS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is COUNTRY MOTORS, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is to conduct business for the sale of automobiles, and for any purpose authorized by Florida Statutes and permitted by law.
