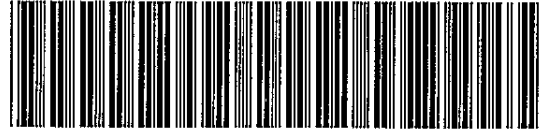

ARTICLE ONE
