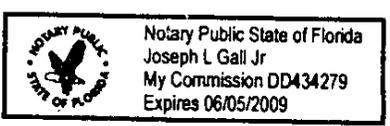
1. Kevin Egan is the President of TREASURELINK, INCORPORATED, a Florida corporation, (hereinafter "Corporation").
