ARTICLES OF INCORPORATION
OF
ROMAN CENTER FOR REHABILITATION, INC.

ARTICLE I - NAME

The name of this Corporation is ROMAN CENTER FOR REHABILITATION, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles of Incorporation are filed with the Florida Secretary of State's Office.

ARTICLE III - PURPOSE
