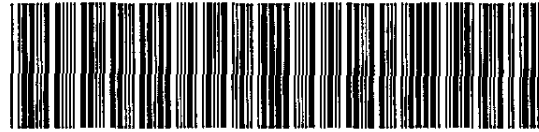

ARTICLE V OFFICERS AND DIRECTORS

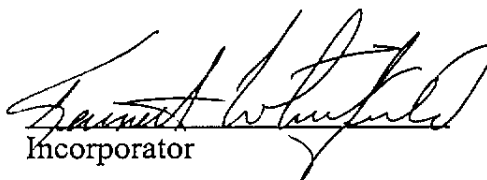

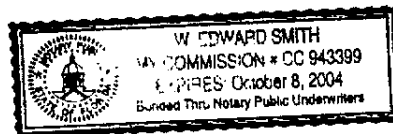
