ARTICLES OF INCORPORATION OF TIME TABLES, INC.

A CAMASSALL COMMON

Article I. Name.

The name of this corporation is **TIME TABLES, INC.** Its address is 106 N. Osceola Avenue, Inverness, FL 34450.

Article II. Purpose.

This corporation is organized for the purpose of transacting any or all lawful business.

Article III. Capital Stock.

This corporation is authorized to issue Ten Thousand (10000) shares of One Dollar (\$1.00) par value common stock.

Article IV. Preemptive Rights.

Every shareholder, upon the sale for cash or any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
