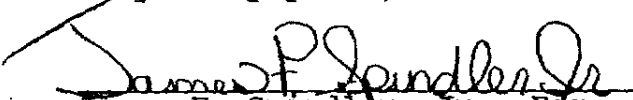

ARTICLES OF INCORPORATION

OF
R.J. BROSSEAU CORPORATION, a Florida Corporation

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is R.J. BROSSEAU CORPORATION, a Florida Corporation.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general nature of the business to be transacted by this corporation shall be:

1. To engage in the business of installing window treatments, and all other activities relating thereto.

3. To do such other things as are incident to the foregoing or necessary or desirable in order to accomplish the foregoing.

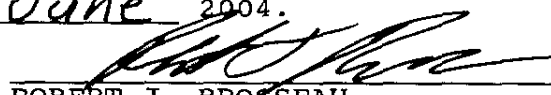

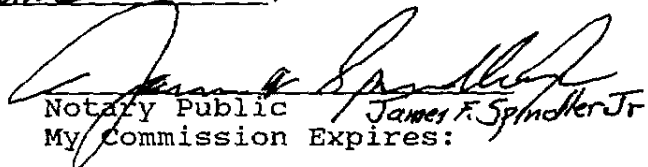
