

ARTICLES OF INCORPORATION OF:

ROMO'S CAFE, CORP. 4183 East 10th Court Hialeah Florida 33013

ARTICLE I - NAME

The name of this componation is: ROMO'S CAFE, CORP.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

ARTICLE III - PURPOSE
