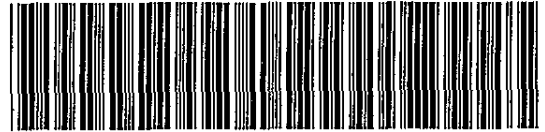

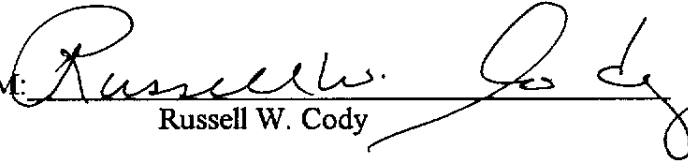

ARTICLES OF INCORPORATION
OF

I, the undersigned do hereby form a corporation for the purpose hereinafter stated and do hereby certify as follows:

ARTICLE I - NAME

The name of the corporation shall be and is hereby declared to be TIBURON TRANSPORTATION SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE

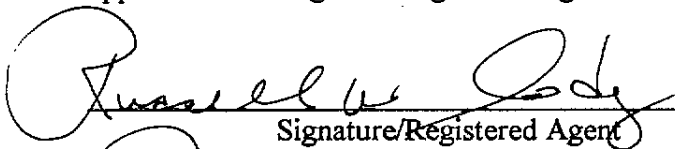
ARTICLE VI - REGISTERED AGENT

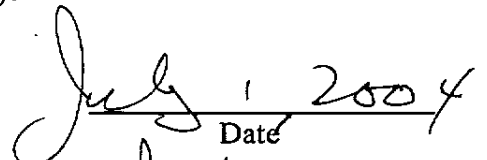
ARTICLE VII - INCORPORATOR

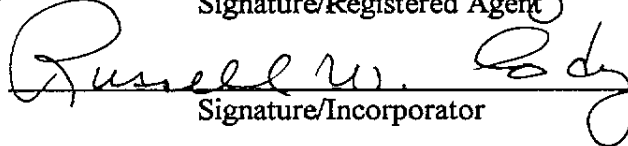

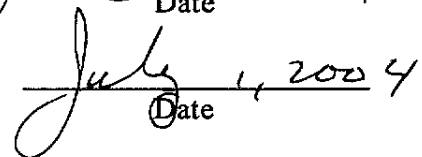

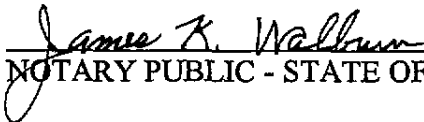
