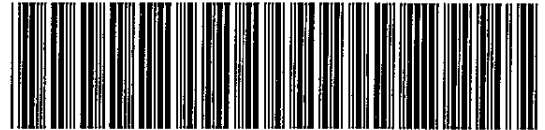

ARTICLE ONE

The name of the corporation is Attention Get-ers Promo's, Inc.

ARTICLE TWO

The period of its duration is perpetual. The effective date for the corporation shall be July 1, 2004

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
