

ARTICLES OF INCORPORATION
OF
THE WINSULATOR, INC

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name the Company shall be THE WINSULATOR, INC.

ARTICLE II

Principal Office and Address

The principal place of business and mailing address is 2033 Main Street, Suite 304, Sarasota, Florida 34237.

ARTICLE III

Duration

The duration of the Company is perpetual.

ARTICLE IV

Purpose

The general purposes for which the Company is organized are the following:

- a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE V

Capital Stock

The aggregate number of shares which the Company is authorized to issue is 7,500 shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE VI

Initial Registered Office and Agent

ARTICLE VII
Initial Board of Directors






