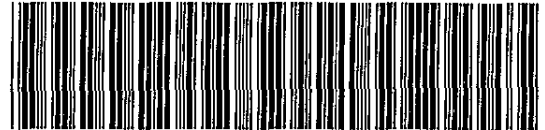

ARTICLES OF INCORPORATION
of

ARTICLE ONE

The name of the Corporation is PRACTICE SHADES, INC.

ARTICLE TWO

The period of its duration is perpetual.


