

ARTICLES OF INCORPORATION OF COATINTERIM BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be CQA INTERIM BANK and its initial place of business shall be at 1020 West Granada Boulevard in the City of Ormond Beach, in the County of Volusia, and State of Florida.

ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 858.40(4) of the Florida Statutes.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 2,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$50 paid-in capital stock to be divided into 10 shares. The amount of surplus and undivided profits with which the corporation will begin business will be \$950.00.

ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.

ARTICLE V
