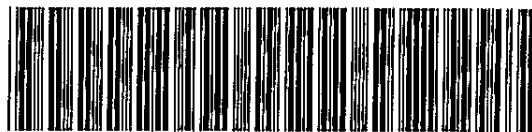

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Home-Purchase-Leads.com, Inc. and its principal place of business shall be located at 9300 5th Street N. St. Petersburg, FL 33702.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE
