**ARTICLES OF INCORPORATION
OF
ARIANNA C. ARANA, P.A.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is ARIANNA C. ARANA, P.A. (hereinafter called the "Corporation").

**ARTICLE II
PURPOSE**

The purpose of the Corporation and the nature of its business are as follows:

1. To engage in the practice of law and to provide services incident thereto.
2. To transact and engage in any and all business activities for which professional service corporations may be organized and in which they may be engaged under Florida law.
3. To do everything necessary, proper or convenient for the accomplishment of such purpose, and to do every other act incident thereto which is lawfully permitted.
