I am sending in my payments for two corporations of \$150 each. I did not receive the notices. I did see my old address of 4108 Stall Road, Tampa FL on your website when I pulled up my info. However, the annual report document does have the correct address on it. I am not using the attorney of David Jeffries any longer, so he did not inform me of this event. If you mailed it to him, he did not contact me, nor did my CPA. I woke up on June 1st and thought the deadline was May 31st. I am so very sorry for this delay.

This letter is to let you know of my extreme financial dilemma and that there is no way that I can afford the extra \$400 on either of these corporations. After owning Curves, Significant Enterprises of Hyde Park for 4 years, I am still not profitable and do not take any funds from this source. My husband's income is cut in half every summer for 8 months and we cannot keep up with our current obligations at this point. We have inherited two teenage girls from a death in the family and we are raising them after their father died. Next we will not be able to pay our credit cards and they will go into default this month. Our mortgage has gone up as it is an arm and we are filing a short sale on both of our properties. There is just no possible way that we have an additional \$800 to pay this penalty with all of our obligations.

Please consider this regular fee sufficient for my two corporations.
