We, the undersigned, hereby associate ourselves for becoming a corporation under the laws of the State of Florida, under the provisions of the Statutes of the State of Florida providing for the information, rights, privileges, ammunition and liabilities of corporation for profit in accordance with Chapter 608 of the Florida Statutes

ARTICLE I

The name of the Corporation shall be:


