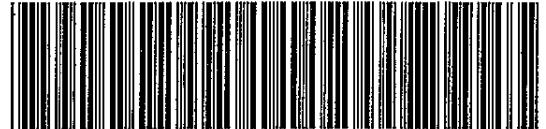

ARTICLE I - NAME

The name of this corporation is GCI – Guarneri Construction, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
