The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be **HonVil Services, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The street address and the mailing address of the corporation's initial principal office is **3938 Warren Street, Sarasota, FL 34233.**

ARTICLE III - DURATION

This corporation shall exist perpetually.

ARTICLE IV - PURPOSE

The specific purpose for which this corporation is organized is to furnish office-cleaning services, as well as to transact any or all lawful business transactions.

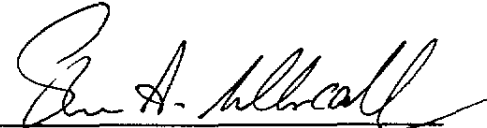

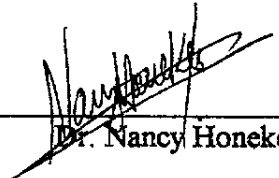
