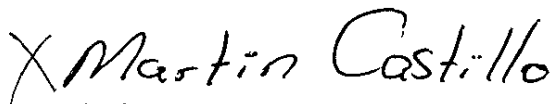
I've enclosed the annual report for your review and processing and my check in the amount of \$150.00.
