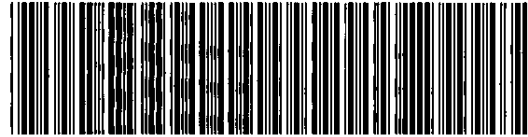




Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following Amendments to its Articles of Incorporation:

I hereby accept appointment as Registered Agent. I am familiar with and accept the obligations of the position.


