The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be Southeastern Precision Firearms, Inc.

ARTICLE II

Principal place of business and mailing address


