I contacted your offices today after it was brought to my attention by a creditor that our corporation has become inactive. I was never informed of SunBiz or that our corporation required any type of renewal. I incorporated AppDevel.com, Inc., 7/22/2004 from LegalZoom.com, a legal website. My business has always been headquartered at my home address. I was married in July of 04 and we purchased a new home 9/30/2004. When I married and moved I updated the IRS and FL Dept. of Revenue. I was never aware of SunBiz or I would have updated the information there as well. I think that the problem occurred because my renewal period was more than six months after my mail forwarding began. This means my forwarding was no longer active when your renewal would have arrived. So the renewal was not forwarded to my present address and I was never aware of needing to renew.

My main goal is to reinstate our file and provide you with the correct contact information. I have enclosed a check for \$300, which a person at your office told me to include with these documents. I understand that there is no guarantee that you will void the extra fees for reinstatement. I would very much appreciate if you are able to. I will also make sure that our renewals are filed on, or before our renewal date. If you are unable to void the extra fees please contact us so that we can send the additional payment to your office. We would like to reinstate as quickly as possible so that we can continue with our credit application at Wachovia.
