

ARTICLES OF INCORPORATION

ARTICLE I - NAME . .

The name of this corporation is Great Walls of Palm Beach, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be 53 Laurel Oaks Circle - E Tequesta, Florida 33469

-ARTICLE III - PURPOSE
