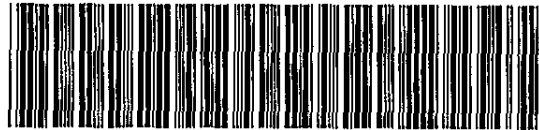

The undersigned, for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE I.
NAME

The name of this corporation shall be **JUANITA W. EDWARDS, INC.** (hereinafter called the "Corporation").

ARTICLE II.
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is **2113 BONISLE CIRLCE, PALM BEACH GARDENS, FLORIDA 33418.**

ARTICLE III.
PURPOSE

The Corporation is a for profit organization organized for the purpose of engaging in any lawful act or activity for which for profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida.
