1. The text of the amendment is as follows:

Article IV of the existing Articles of Incorporation of the Corporation, which relates to corporate shares, is hereby deleted in its entirety and the following new Article IV shall be inserted in lieu thereof:

## ARTICLE IV CORPORATE SHARES

The corporate shares authorized and the class of such stock shall be as follows:

Holders of Class A Common Stock shall have the same rights and preferences as the holders of the Class B Common Stock, except that the holders of the Class A Common Stock shall have voting rights and holders of the Class B Common Stock shall have no voting rights whatsoever.

The Board of Directors shall be authorized to issue additional shares of Class A and Class B Common Stock from time to time as may be necessary and appropriate. Such increase of the number of authorized shares will require the affirmative vote of the holders of a majority of the voting shares of the company.

All powers, rights, qualifications, limitations or restrictions on capital stock not expressly provided for in the certificate of incorporation may be adopted by resolution by the Board of Directors.

3. The Amendment was unanimously adopted by the Director and Shareholder of the Corporation on December 21, 2010.
