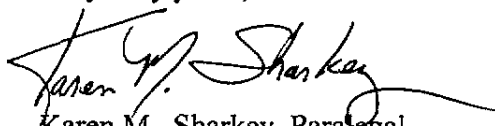

The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of this Corporation is **SIGNATURE CAFÉ, INC.** The principal and mailing address of this Corporation shall be 606 North Franklin Street, Tampa, Florida 33602.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence unless dissolved according to law.

**ARTICLE III - PURPOSE**

The purpose for which this Corporation is organized is to engage in any and all lawful business activities permitted under the Laws of the United States and the State of Florida. The Corporation shall have power to do everything necessary, proper, advisable, and convenient for the accomplishment of the purposes hereinafter set forth and to do all other things incidental thereto or connected therewith which are not prohibited by statute or by these Articles of Incorporation.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is One Hundred (100) shares of common stock having a par value of \$1.00 per share, each of which shall have the same rights and privileges.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Corporation shall be 535 Central Avenue, St. Petersburg, Florida 33701, and the initial Registered Agent of this Corporation at such office shall be THOMAS E. REYNOLDS, ESQUIRE, who, upon accepting this designation, agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

**ARTICLE VI - INITIAL BOARD OF DIRECTORS**

The initial Board of Directors shall consist of one (1) member. The number of Directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of Directors be less than one (1) nor more than five (5). 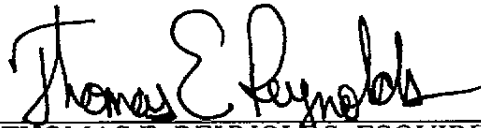
