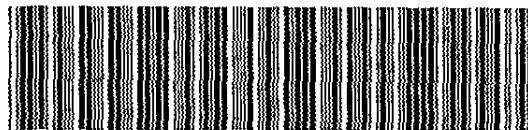

**ARTICLES OF INCORPORATION
OF
L & M TRANSPORTATION EXPRESS, INC.**

ARTICLE I - NAME

The name of this corporation is **L & M TRANSPORTATION EXPRESS, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue **ONE HUNDRED (100)** shares of \$1.00 par value common stock, which shall be designated "Common Stock".

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.




