ARTICLES OF INCORPORATION

OF

HELP 4 SENIORS MOBILE SERVICES ETC., INC.

We, the undersigned, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, in accordance with the following Certificate of Incorporation.

ARTICLE I

The name of this corporation shall be <u>HELP 4 SENIORS MOBILE SERVICES ETC.</u>, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is **Providing Services to Senior Citizens**. To engage in any activities or business permitted under the laws of the United States and of this State, except that it shall not engage in the raffroad, canal, telephone, or telegraph business.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at one time shall be 1000 shares of common stock having a nominal or par value of \$1.00 per share. The consideration to be paid for each such share shall be money, property, or service of value at least equivalent to the stock issued as fixed and determined from time to time, by the Board of Directors.
