### ARTICLES OF INCORPORATION OF EVERALDO CUEVAS, PA

I, the undersigned, desiring to form a corporation for the purposes hereinafter stated, under and pursuant to Chapter 607 of the Florida Statutes, do hereby declare as follows:

### ARTICLE 1

NAME

The name of the corporation shall be: EVERALDO CUEVAS, PA

### ARTICLE II BUSINESS AND POWERS

The corporation may engage in any activity or business permitted under the laws of the United States and of the state of Florida.

### ARTICLE III STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be 1,000 shares of common stock having a par value of \$1.00 per share The capital stock may be paid for in property, labor or services at a just valuation, to be fixed by the incorporators or by the directors at a meeting called for such purposes or at the organization meeting. This corporation shall have a perpetual existence.

### ARTICLE VII BOARD OF DIRECTORS

The affairs of the corporation shall be conducted by a board of not less than one nor more than five directors.
