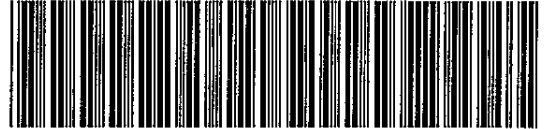

ARTICLES OF INCORPORATION OF *The Kearley Corporation*

ARTICLE I. NAME
