ARTICLE I - NAME

The name of this Corporation is W. FRANK WASHINGTON CONSULTING, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

A. To engage in consultant and advisory work relating to all manner of political endeavors including, but not limited to, the organization, financing, management, operation and re-organization of political campaigns, offices and the like.

B. To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which this Corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of One (\$1.00) Dollar par value common stock.


ARTICLE X - INDEMNIFICATION



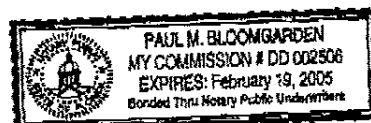


