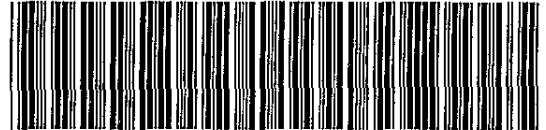

The undersigned, acting as incorporator of corporation pursuant to Chapter 607, Florida Statutes adopts the following Articles of incorporation for such corporation.

ARTICLE I NAME

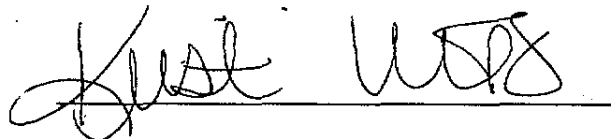
