### ARTICLE I

The name of the corporation is LATIN MEDIA INVESTMENTS CORPORATION (hereinafter called the "Corporation").

### **ARTICLE II**

### **ARTICLE VI**

The Board of Directors of the Corporation shall consist of at least one (1) director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.

## **ARTICLE VII**

The name of the Incorporator is Joan Burton Jensen.

## **ARTICLE VIII**

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
