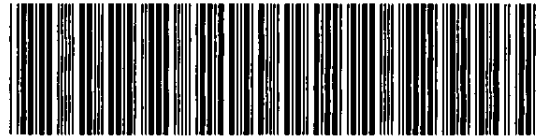


We closed our doors March 1, 2008
